Guidelines & Applicant Criteria

Mission of Scholarship Program:

360 Federal Credit Union is committed to helping our members achieve lifelong success by providing financial support to a deserving undergraduate member attending an institution of higher education.

Eligibility:

Applicant must be planning to attend an accredited institution of higher education such as a two-year or four-year college.

• Applicant must be a graduating high school senior, or college student planning to attend an accredited institution of higher education in the Fall.

Applicant must be a member of 360 Federal Credit Union.

Applicant must have a solid academic standing, with a Grade Point Average of 3.0 or better.

Submitting Scholarship Applications:

Applications will be accepted until **May 1st** for the following academic year (which begins in the Fall). Applications and supporting documentation must be mailed or dropped off to one of our branch locations (Sorry, no e-mail or faxed applications will be accepted). Documents should not be stapled together. Completed applications should be submitted no later than May 1st.

IMPORTANT: Applications will be considered complete and valid when all the documentation has been received. Any incomplete application packages will be disqualified. *Current 360FCU employees and their families are not eligible to apply. Selection Process:

360 Federal Credit Union will award \$1,000.00 in scholarship funds to a member(s) who best meets the criteria established by 360's Scholarship Committee. All applicants will be notified in writing of the Scholarship Committee's decision. 360 Federal Credit Union reserves the right to publicize the names and image of scholarship recipients through our website, print publications and other local media.

Scholarship Disbursement:

Scholarship check will be sent directly to the college the recipient will be attending. Scholarship funds can be used only for college expenses. Should the recipient not attend college by September, he or she agrees to forfeit the scholarship award.
